Yellow Diva Warranty

CP Series

A 3 year commercial warranty applies for the CP Series.

This warranty covers the CP ottomans, chairs and stools against structural defects in the steel framework.

The rope used is UV stable and marine grade and suitable for extended outdoor use.

Yellow Diva is unable to guarantee against scuffing, chipping or fading of decorative powder coat finish. This warranty does not cover any damage that may be caused by what can be deemed normal wear and tear*.

Products must be cared for according to the care and maintenance instructions provided. Yellow Diva will not accept responsibility in any way for damage caused by neglect, misuse, abuse or accident and such damage shall be construed as a breach of the warranty contract.

Special or custom items may be subject to additional conditions.

*Normal wear and tear for CPO3 ottoman is deemed to be regular use as seating by up to 5 persons at any one time and continued exposure to the elements under typical weather conditions. Some fading of certain colours may occur with prolonged exposure to full sun. Please note that these products were not designed as playground equipment and it is recommended that children remain under the supervision of a responsible adult.

Hang Series

A 3-year commercial structural warranty applies for Yellow Diva Hang, Hang 5, Hang 10, Hang Loose & Hang Luxe.

This warranty covers product against splitting or delamination of the timber elements and structural failure of the steel frames. It is the responsibility of the client to ensure floor weights are positioned as recommended. Do not overload plywood boxes.

It is the responsibility of the client to ensure Hang Loose is secure and properly hung from an adequate structural point.

This warranty does not cover any damage that may be caused by what can be deemed normal wear and tear. Yellow Diva is unable to guarantee against scuffing, chipping or fading of decorative powder coat finish. This warranty is limited to indoor use. Products must be cared for according to the care and maintenance instructions provided.

WBX Series (outdoor)

A 3-year commercial warranty applies for Yellow Diva WBX Series (outdoor)

This warranty is limited to furniture used in undercover 'alfresco' areas.

This warranty covers WBX outdoor range of stools (WBSX), tables (WBTX) and bench seats (WBBX) against structural failure of the timber tops, steel leg frames or fixings. WBX outdoor range is manufactured from Spotted Gum, a sustainable timber native to Australia. End checking of the timber may appear and is not claimable under warranty. Tannin may leach from the timber and cause temporary discolouration to the leg frame. Any changes in the visual appearance of the timber that are directly linked to ageing are not covered by the warranty.

This warranty does not cover any damage that may be caused by what can be deemed normal wear and tear. Yellow Diva is unable to guarantee against scuffing, chipping or fading of decorative powder coat finish.

Products must be cared for according to the care and maintenance instructions provided. Staple Stool

This warranty is limited to indoor use. Please note that if product is kept in direct sunlight the UV radiation may cause the wood surface to darken under the coating.
